Learning Outcomes

### RESEARCH METHODOLOGY

At the end of the course, students are able to:

- (1) Examine the logic of scientific discovery and the novelty in research.
- (2) Evaluate the usage of inductive and deductive research.
- (3) Compare the different types of research methodologies.
- (4) Formulate a research proposal.

Synopsis of Course Contents

Using examples from past research and methodologies across 4 disciplines (economics, applied statistics, development studies and politics), this course seeks to examine in its entirety the philosophy and methodology of research so as to help equip students with a better understanding of how to undertake research, analyse data, and write scholarly and policy papers. Following a sequential exposition of the philosophical underpinnings of research and methodology, and the procedures of data collection, estimation and interpretation, the course introduces all the main current methodologies as well as qualitative and quantitative tools of data analysis.

Lectures will be supplemented with a critical examination of the methodological frameworks used in selected leading publications and by leading scholars from inter/disciplinary fields.

In class lessons will be revisited towards the end of the course through a careful selection of case studies from multiple disciplines (tier 1 journal publications from economics, applied statistics, dev studies and politics). This way, students will have a broad introduction to various ways in which data, methodologies, software and methods are combined in academic research. The emphasis will be on methodological debates and diversity within social sciences. Equally, they will receive practical lessons on how to handle discipline-specific big data sets.

Lastly, they will receive hands-on training on complete research proposal developments applying creative and critical thinking using problem sets.

**RESEARCH PROJECT****Learning Outcomes**

At the end of the course, students are able to:

- (1) Determine a suitable topic for actual problems, objective and background of research based on actual issues in organization or industry.
- (2) Analyse information from the relevant literature and design a research framework.
- (3) Determine the appropriate methodology in collecting the required data.
- (4) Integrate the information/ data collected.
- (5) Prepare written research report

**Synopsis of Course Contents**

The course is designed to train students in conducting research in public administration and writing a research paper. Each student is guided by one supervisor from faculty and can be together from industry experts from the development of a research project to the completion of the research report. The stages include identification of issues, establish problem statement, research questions, research design, literature review (analysis, synthesis and critic of empirical research and theory), data collection, data analysis, analysis of the findings to answer the research questions, and drawing appropriate conclusions.

- (4) Assess an understanding of public management as it relates to global issues, and association with activities of transnational and regional organizations.

**Synopsis of Course Contents**

This course aims to identify significant recent and current international developments in public management theories and practices including the processes and related debates as well as reforms. The course also addresses the roles and specific challenges faced by public managers in the current world of rapid change and increased expectations as it relates to global issues and key developments with public management related activities of transnational and regional organizations such as World Bank, ADB, EU, OECD, UNDP, ASEAN, etc.

- (3) Evaluate policy implementation and its impact on national development from the perspectives of economy, politics, social and institution in developed and developing nations
- (4) Suggest relevant policies formulation and implementation in developed and developing nations

**Synopsis of Course Contents**

This course deals with the explanation of policy analysis models, identification of relevant actors, sources and institutions in public policy as well as examination and evaluation of complex issues that could affect the overall policy cycle process. This course also emphasizes on models and tools of evaluation in public policy analysis and its application by comparing policies among countries.

**FISCAL ADMINISTRATION**

## Learning Outcomes

At the end of the course, students are able to:

- (1) Assess the basic characteristics of fiscal administration in the government financial system.
- (2) Examine the central and local government budgeting processes in terms of economic and political economy.
- (3) Solve issues related to tax policies in public administration.
- (4) Analyze the methods in cost and benefits analysis of government investment projects, taking into account the criteria of efficiency and fairness, in the public interest.

## Synopsis of Course Contents

This course provides the introduction on the policies concerning fiscal administration. This includes the use of public goods and public choices associated with the fiscal administration. The efficiency and equity serves as the major outcome of the fiscal administration. This ranging from the federal government to the state and local governments will be introduced in detail. The course covers budgetary issues, taxation and revenues as well as the debt management of a sound and sustainability economy. It also focuses on fiscal federalism, federal finance, as well as intergovernmental relations and financial adjustment.

- (3) Generate awareness of constructive and effective behaviour in synergistic decision making.

**Synopsis of Course Contents**

This course will explore the importance of public administration behaviour in understanding the functions of the organization, by focusing primarily on individuals and groups as well as understanding human behaviour through the basic disciplines of psychology and sociology.

The perspective of this course includes an understanding of the factors of differences in individual perceptions, synergistic decision making, fostering motivation in the workplace, team and leadership behaviour, and organizational design, change and its development.

- (3) Suggest a dynamic structure of public personnel administration that has impactful to the organization, community, and society.

**Synopsis of Course  
Contents**

This course will provide an understanding on public personnel administration. Topics covered include understanding the internal and external environment, managing organizational and public personnel, recruiting, training and compensation appraisal, career and safety management health, and issues relating to global public personnel administration.

**GLOBAL POLITICS****Learning Outcomes**

At the end of the course, students are able to:

- (1) Review theoretical debates about state-society relations and modes of governance under different political systems as economies develop and are affected by; global events.
- (2) Assess key debates globally about core political and economic issues involving democratic and authoritarian forms of governance and models of development, as well as core issues such as poverty, inequality, social exclusion, religion, terrorism, migration and human rights; and;
- (3) Explain contestations between the state and society in different regions, based on these issues, and how they shape political systems and socio-economic development.

**Synopsis of Course Contents**

This course deals with core issues involving governance, development and justice within countries and regions. Theoretical perspectives within the area of global politics will first be reviewed, to better grapple with pressing issues in society shaped by real world events.

Global events affected by neoliberal development, the rapid rise of China, religious conflicts, terrorism, racism and migration that are contributing to growing state-society contestations within countries will be discussed in this course.

The interaction between local, national and global sources of power within developed and emerging economies will be appraised to determine how they shape domestic political discourses and public policies.

This course explores and analyzes the application of quality theories and approaches, quality governance practices, examines quality planning and implementation based on quality tools and techniques as well as understanding and evaluating issues and problems in quality governance in public sector.

**Synopsis of Course  
Contents**

This course explores the fundamentals form and function of local government in the intergovernmental space. It is designed to meet the needs of students who wish to develop an understanding of local government and urbanisation. This course examines the history of local government, and explaining its complex and varied relationship with higher tiers of government. Finally, it explores the nature, causes of urbanisation distress related to local government, and examines the relevant policies to address them.

- (3) Relate the concepts of planning and community development to social, economic and political forces that shape the environment

**Synopsis of Course Contents**

This course is designed for students to understand planning and community development. It will focus on the nature and purpose of planning and community development, the role of different stakeholders in the planning and community development process and the governance context within which different types of planning operate. The course will use interdisciplinary knowledge and techniques in addressing environmental and social issues of concern to the community. Within this context, it will explore issues facing planners and managers in delivering services and fulfilling community needs. These needs will be discussed within the framework of sustainable development agenda.

This course covers major issues connected with the research process in various fields. The course is designed to equip students with a sound understanding of theory building and the research process, with emphasis on quantitative applications of research methods. Students will learn the techniques of sampling, data collection and analysis for report writing. The course will also train students on critical analysis of published research and equip them with communication skills

**STATISTICAL METHODS FOR QUALITY MANAGEMENT**

**Learning Outcomes**

At the end of this course, students are able to:

- (1) Explain the role of statistical methodology, tools and techniques for quality management in the field of social science.
- (2) Apply the appropriate statistical tools, techniques and software applications in describing quality characteristics.
- (3) Analyse statistical results in solving quality related problems.
- (4) Construct various forms of results to effectively communicate on findings about quality

**Synopsis of Course Contents**

This course exposes students to basic concepts of quality and the roles of statistical methods in understanding and managing quality of processes and products. Statistical software is utilized in understanding the process and product quality characteristics. The topics covered include Statistical Thinking in Quality Improvement, Statistical Process Control, Variable and Attribute Control Chart, Hotelling's T<sup>2</sup> Control Chart, Multivariate Methods for Quality Improvement, Acceptance sampling.

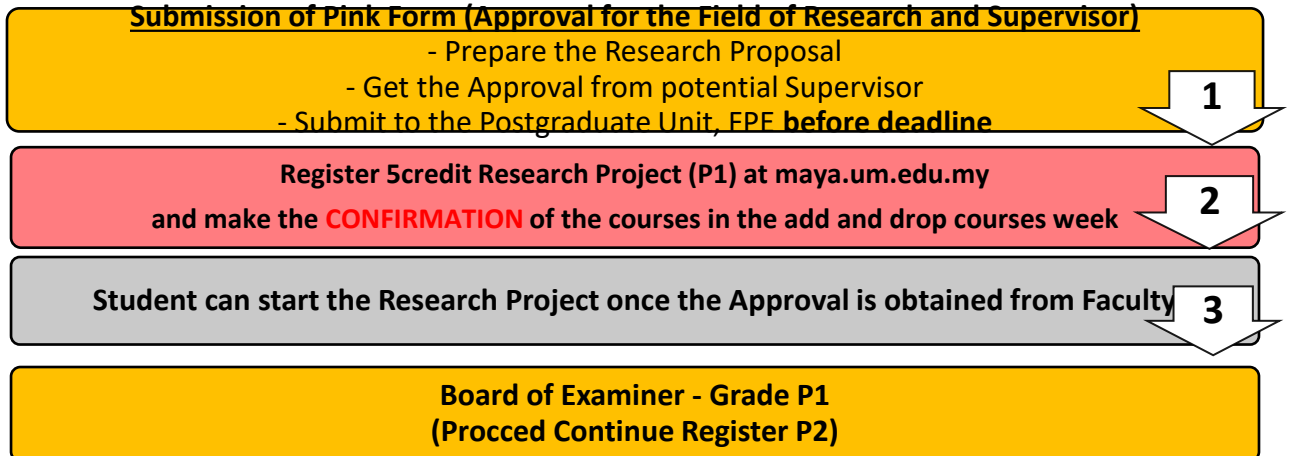

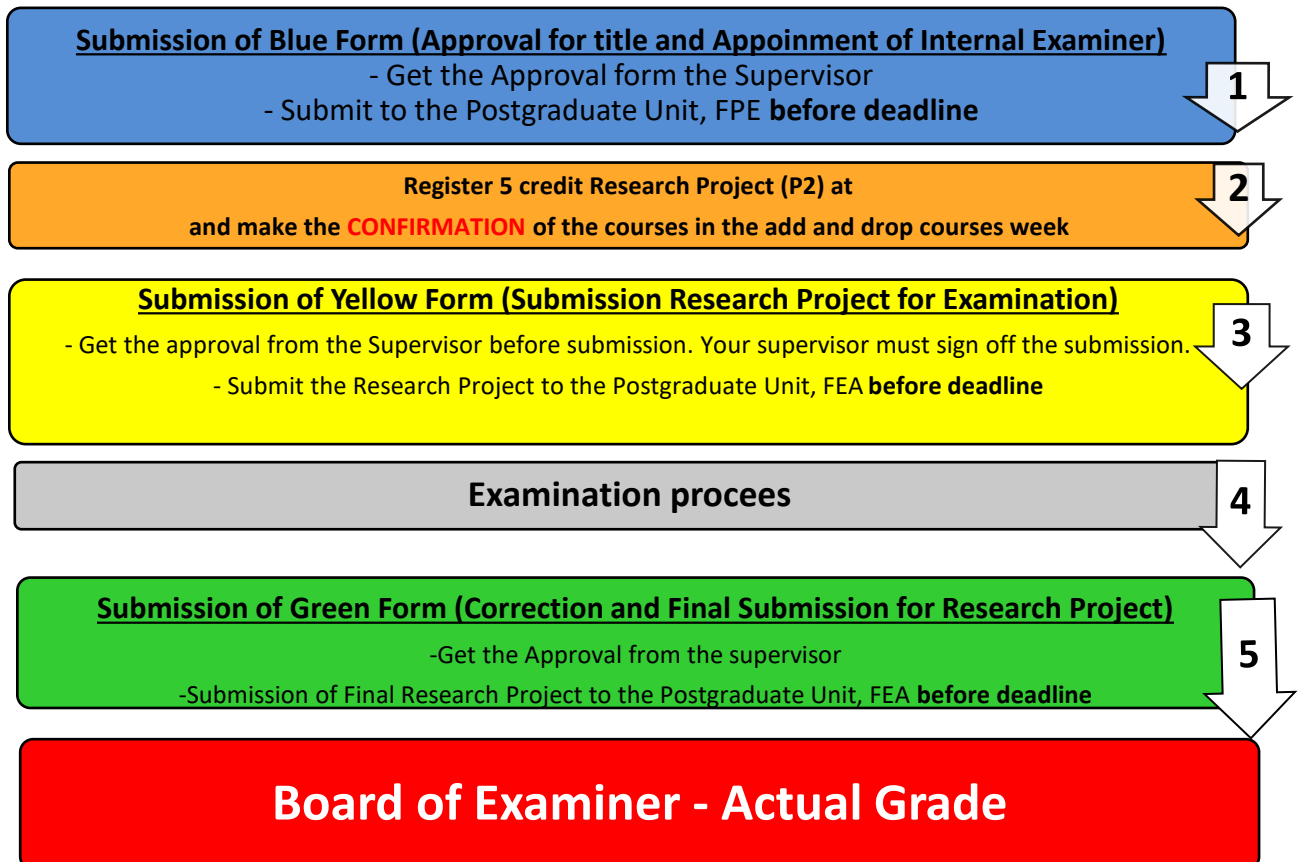

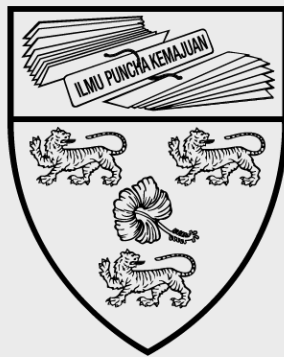
