1. What is UM Research Ethics (UMREC)?

- ➤ The UM Research Ethics Committee (UMREC) is the entity that undertakes ethics reviews of all non-medical research involving human participants, including both funded and unfunded research conducted by the UM community.
- All research projects led by UM community members are recommended to obtain ethical clearance as part of good research governance practices, ensuring the voluntariness of subjects/participants and aligning with the requirements of most academic journals for publication.
- Data collection and participant recruitment are strictly prohibited before obtaining ethical clearance, subject to the UMREC's approval.

2. Where do I send my UMREC Application Form for endorsement/verification?

- ➤ Please make sure the form & compile all supporting documents into a/single PDF file and send it by email to Mrs. Mazlita Ahmad (admin asst.) at maz79@um.edu.my and cc to FBEc Deputy Dean (Research and Innovation) at tdp fpe@um.edu.my.
- Faculty only endorses/verifies your application form. Once you've received the signed copy from us, please submit the complete documents by email to mailto:umrec@um.edu.my for UMREC's approval.

3. What is UMExpert?

- ➤ It is an academic portal showcasing the university's research talent and scholarly output.
- UMExpert serves two (2) main functions:
 - 1. It is a public reference platform for searching and identifying experts within Universiti Malaya (UM).
 - 2. It is an internal system for academic staff to submit their Key Performance Indicator (KPI) items for annual KPI evaluation.

5. As a staff member, why are my KPI marks in UMExpert still not updated, despite PTj having verified my KPI items?

- In some cases, this may be due to the KPI items not being entered per the KPI Criteria & Operational Definitions (available in the RMS Dashboard) required for the system to generate KPI marks.
- As such, requests to include past entries (no double counting) in the current year's KPI calculation, or whenever advised by the faculty officer, please get in touch with the Corporate Performance Centre directly by email at urusetia cpo@um.edu.my.

6. Does the faculty provide funding support for research?

- Subject to funds availability, the faculty does offer internal grants that all faculty members are welcome to apply for.
- Some of the most commonly pursued internal grants include research grants and book grants (GPKF, GBKF, FARG). Whereas, matching and teaching material development grants (FSMG, FSIMDG) are typically available upon announcement.
- ➤ In addition to internal grants, the faculty also offers a Special Publication Fund to cover costs incurred before the publication of research findings as articles or books in reputable academic journals or by recognized publishers.
